INREIT's Board of Trustees, acting as general partner of INREIT Properties, LLLP, also approved a distribution of \$0.171875 per unit to Limited Partnership unitholders of record as of March 31, 2006. This distribution is also payable on April 17, 2006.

This is the 12th consecutive quarterly dividend, and distribution, paid by INREIT and equates to a 6.25% annual yield for shareholders given INREIT's current share price.
