MINOT, NORTH DAKOTA – INREIT Real Estate Investment Trust (INREIT) announced today its Board of Trustees approved a fourth quarter 2005 dividend of \$0.165 per share to shareholders of record as of December 31, 2005. This dividend is payable on January 15, 2006.

INREIT's Board of Trustees, acting as general partner of INREIT Properties, LLLP, also approved a distribution of \$0.165 per unit to Limited Partnership unitholders of record as of December 31, 2005. This distribution is also payable on January 15, 2006.

This is the 11th consecutive quarterly dividend, and distribution, paid by INREIT and equates to a 6.0% annual yield for shareholders given INREIT's current share price.

INREIT operates as an Umbrella Partnership Real Estate Investment Trust, and holds all of its assets through INREIT Properties, LLLP, which INREIT controls as general partner.
