MINOT, NORTH DAKOTA – INREIT Real Estate Investment Trust (INREIT) announced today its Board of Trustees approved a first quarter 2009 dividend of \$0.18625 per share to shareholders of record as of March 31, 2009. This dividend is payable on April 15, 2009.

INREIT's Board of Trustees, acting as general partner of INREIT Properties, LLLP, also approved a distribution of \$0.18625 per unit to Limited Partnership unitholders of record as of March 31, 2009. This distribution is also payable on April 15, 2009.

This is the 25th consecutive quarterly dividend, and distribution, paid by INREIT and equates to a 5.32% annual yield for shareholders given INREIT's current share price.
