MINOT, NORTH DAKOTA – INREIT Real Estate Investment Trust (INREIT) announced today its Board of Trustees approved a second quarter 2003 dividend of \$0.15 per share to shareholders of record as of June 30, 2003. This dividend is payable on July 30, 2003.

INREIT's Board of Trustees, acting as general partner of INREIT Properties, LLLP, also approved a distribution of \$0.15 per unit to Limited Partnership unitholders of record as of June 30, 2003. This distribution is also payable on July 30, 2003.

This is the 1st quarterly dividend, and distribution, paid by INREIT and equates to a 6.0% annual yield for shareholders given INREIT's current share price.

INREIT operates as an Umbrella Partnership Real Estate Investment Trust, and holds all of its assets through INREIT Properties, LLLP, which INREIT controls as general partner.
