MINOT, NORTH DAKOTA – INREIT Real Estate Investment Trust (INREIT) announced today its Board of Trustees approved a third quarter 2008 dividend of \$0.18375 per share to shareholders of record as of September 30, 2008. This dividend is payable on October 15, 2008.

INREIT's Board of Trustees, acting as general partner of INREIT Properties, LLLP, also approved a distribution of \$0.18375 per unit to Limited Partnership unitholders of record as of September 30, 2008. This distribution is also payable on October 15, 2008.

This is the 22nd consecutive quarterly dividend, and distribution, paid by INREIT and equates to a 5.25% annual yield for shareholders given INREIT's current share price.
